I shall update you on our activities from July till date. As you go through, note the two significant registrations which could be “turning points” or game changers for operations of KEATS!

1. FCRA REGISTRATION

We are now registered under Foreign Contribution (Regulation) Act, 2010 with Government of India, Ministry of Home Affairs, Foreigners Division (FCRA Wing).
The registration number dated 3rd August is [68140090](#).
The perseverance of our Managing Trustee in obtaining the registration is placed on record.

2. KEATS USA INC

We are delighted to inform that, with the initiative taken by Jayadev Vellanki, KEATS US Inc has been registered as a non-profit organisation in New Jersey in the third week of August. The initial trustees are Dr Jayadev (Tel: [609 - 577 - 5854](#)), Dr Vijayalakshmi Atluri and Mr Abhinay Venuturumilli. The Federal Tax Id has been received and modalities are being worked to obtain tax exemption for donations under 501(C). Ms Likhitha, Ms Shailaja and Mr Praneet are creating a new website!

3. FOCUS AREA

A sub-committee, under the aegis of Mr Ramesh Narayana, recommended that henceforth EDUCATION should be the area for KEATS to channel all its resources. It was accepted by the Executive Committee.

To start with two schools (VCHS, Moosapet, Hyderabad and ZPHS, Dharmasagar, Warangal) shall be adopted. Metrics shall be used to monitor the progress.

However, any project of interest by a donor in sectors other than education shall also be taken up provided he/she fully finances it.

4. BIG FILLIP



8. SUPPORT TO SCHOOLS DURING LOCKDOWN PERIOD

Some schools receiving support for the past few years from us were facing financial constraints. KEATS pitched in once again by providing funds to :

- a. Orphanage cum school run by CSS, Hayathnagar was assisted with ₹3.00 lakhs.
- b. ₹2.00 lakhs was advanced to VCHS, Moosapet towards staff salaries.
- c. Aalambana was given ₹1.00 lakh to run the school for poor.
- d. Notebooks worth ₹36,000 were distributed to students of ZPHS, Dharmasagar.
