## WOMEN EMPOWERMENT CENTER(WEC)

have made significant progress e with WEC's efforts our towards self-sustainability, particularly with the launch of "KEATS EATS" for marketing its products. Here are some points summarizing our achievements and ongoing activities:

Brand Development and Registration: The name KEATS EATS has been chosen for marketing the products. We have initiated the registration process for the brand name, which is crucial for protection and recognition. But then we decided against independent entry into the retail market due to logistical challenges. Instead M/s GCF will be our marketing partner and will manage retail aspects. Focus will be on marketing KEATS EATS products through our network and in the Hotel Restaurant and Café/Catering (HoReCa) sector.

Partnerships and Collaborations: Discussions are ongoing to collaborate with corporate caterers like COMPASS which could significantly expand our market reach and distribution channels.

Our pickle products have been well received, generating orders and inquiries. They are available for online orders within India, showcasing demand and market interest. There have been issues with accepting international card payments but we are actively working with Razor Pay, our payment gateway partner, to resolve these payment issues, ensuring transactions international smoother for customers.We are open to further leads and collaborations from members to enhance our presence and sales, particularly in corporate catering and related sectors. Overall, our efforts demonstrate a strategic approach to building and expanding our brand while addressing operational challenges effectively. Keep leveraging partnerships and focusing on market segments that align with our strengths and goals.



## SKILL DEVELOPMENT CENTER(SDC)

We are pleased to report that the first two batches of participants trained in the health sector as "Patient Relation Coordinators" (with KIMS Foundation as Knowledge and Training partner) achieved an 82% placement rate. The remaining 18% could not join due to their personal reasons.



Currently, we are focusing on skilling for degree holders in Data Analytics and for Engineering Graduates in Artificial Intelligence & Machine Learning with M/s KC Pullaiah foundation as our Knowledge and Training partners. SDC is a program that requires continuous fund raising to help rural unemployed and financially disadvantaged youth. We are making efforts to partner with other NGOs and corporate entities for funds. We request support from our trustees and philanthropists as well for this cause.

Further proposals are under consideration to train 50 to 100 youth with a minimum qualification as drivers, with Maruti as training partner. M/s EVZIP Mobility Pvt Ltd, a startup with a fleet of electric cars for corporate hiring and last-mile connectivity with Metro (still under approval) will be the employment partner.



## **EDUCATION**

The Vissanapeta Tribal School & Junior College's digital classroom project and infrastructure improvement project are in advanced stages. The digital classroom project is a collaboration with Rotary Midtown Vijayawada as the host club, Rotary Burlingame as international partner, with matching contributions from the International Rotary Fund. The IRF grant is under approval. Our role will be as an implementing partner.

Regarding infrastructure improvement, we are CSR implementing partners for Dr. Reddy's Laboratories. An amount of Rs80.00 lakh grant has already been approved and received last week. The project will start in the second week of July.

We (KEATS) have aligned with another trust MANCHIPUSTAKAM in fostering



reading habit amongst children.Recently the trust has completed 20 years of service in publishing and promoting low-cost children's books.KEATS decided to donate their books worth Rs 1.00 lakh to libraries of about 25

schools, most of which are long term associates.

## Smt VELLANKI LEELAVATHI RAGHAVAIAH EXTENSION BLOCK AND LIBRARY ROOM @ CSS-NAM SCHOOL:

A lthough KEATS is not directly involved in this program, it would be grossly unjust if the event is not reported here in our communication journal. On 24th June, the additional infrastructure created at CSS-NAM English Medium School at Hayathnagar was inaugurated. Dr Jayadev Vellanki, President KEATS-US and Dr Venkatarao Mulpuri helped Mrs Vijayalakshmi Vemuri of Center for Social Service mobilise the funds required during their fund raising trip to US last year.



Jayadev and Prof Vijayalakshmi Atluri set an example by contributing Rs 50.00 lakhs towards the extension block and their daughter Dr Priya Velanki donated Rs 10.00 lakhs. s you may be aware, our Skill Development ACenter (SDC) located in Ambarupeta, NTR Dist., is dedicated empowering to unemployed youth in rural areas by equipping them with the necessary skills for employment opportunities. However, we currently face a challenge in accessing Government support, such as reimbursement through the Deen Daval Upadhyaya Grameen Kaushalya Yojana (DDU-GKY), due to delays in the registration process. While we continue to resolve this issue, we are actively seeking assistance from various avenues, including Corporate Social Responsibility (CSR) initiatives, NGOs, and contributions from our members. To provide comprehensive training to each participant, we estimate a requirement of approximately Rs. 16,000 for training expenses and Rs.18,000 for boarding and lodging. It's worth noting that all contributions made by Indian donors are eligible for IT exemption u.s. 80G.

We humbly request your support in sponsoring the full expenses for one participant or contributing towards any specific component. Your generosity will enable us to sustain our efforts in empowering and engaging youth in constructive endeavors. Our goal for this year is to train around 250 participants, and your support will significantly contribute to achieving this objective.
